## Farmhouse Animal & Nature Sanctuary Awarded \$22,000 Grant From Community Foundation of Sarasota to Support the Purchase of a Used Tractor

Farmhouse Animal & Nature Sanctuary (FANS), a nonprofit exotic, domestic and farm animal sanctuary, recently was awarded a \$22,000 Animal Welfare Grant. Funding for the grant was provided by the Robert Parker Fund of the Community Foundation of Sarasota County.

The purpose of this grant is to purchase a used tractor/backhoe/ loader to help lighten the workload at the sanctuary. The tractor will enable volunteers to care for the organization's rescued animals more efficiently and affordably.

As a sanctuary for rescued farm animals and other types of alternative pets, FANS sits on six acres of property that includes fencedin pastures, paddocks and specially-designed habitats.

Caring for the sanctuary's rescued animals is the priority, and that task involves more than filling food bowls and scheduling vet appointments. Maintaining the farm property is essential to the health, safety and well-being of each animal. Hurricane Ian heightened this need by destroying the majority of the sanctuary's perimeter fence and ripping out 35-plus trees on the property. Currently, these chores are either done by hand or with rented equipment and takes up to several hours of volunteer time and costs hundreds of dollars each quarter. This is not the most efficient way to operate, and it restricts how many animals the sanctuary can take in.

The solution: Purchase of a used tractor that will allow FANS to accomplish essential tasks more quickly and save money.

The to-do list at the farm sanctuary is never ending, and the ongoing problems related to animal safety and well-being can be solved with this single purchase.

The mission at Farmhouse Animal & Nature Sanctuary, a 501(c) (3) nonprofit founded in 2017 in Myakka City, is to care for, love and support the exotic and farm animals that live at the sanctuarv. to the best of our ability. for the remainder of their lives and to educate the public about animal care.

The Community Foundation of Sarasota County is a public charity founded in 1979 by the Southwest Florida Estate Planning Council as a resource for caring individuals and the

causes they support, enabling them to make a charitable impact on the community. Since its founding, the Community Foundation has been able to grant more than \$396 million to area nonprofit organizations to our community thanks to the generosity of charitable individuals, families, and businesses.

Currently 136 animals reside at the sanctuary—from horses, pigs and goats to tortoises, kangaroos and prairie dogs. Many animals come FANS due to neglect, age and medical needs or their families simply could no longer care for them.

FANS partners with both Manatee County Animal Welfare and Sarasota Sheriff's Animal Services, as well as FWC's amnesty program, taking in animals that were confiscated and/or abandoned.

Why they arrive isn't as important as how they will spend the rest of their lives: Safe and secure, in a habitat as close to nature intended as possible.
